Who regulates telecommunications in Argentina?

ENACOM(Ente Nacional de Comunicaciones),formerly known as AFTIC and CNC,is the telecommunications regulatory agency in Argentina since 2015. Products that using technologies such as radio frequency,cellular,or satellite require ENACOM type approval and certification to be commercialized in Argentina.

Do you need ENACOM certification in Argentina?

Products that using technologies such as radio frequency,cellular,or satelliterequire ENACOM type approval and certification to be commercialized in Argentina. Most products require testing in Argentina,and typically one to three samples are needed depending on the device.

How to import & commercialize Telecom and electronic equipment in Argentina?

To import and commercialize telecom and electronic equipment in Argentina,manufacturers and importers must comply with local regulationsenforced by ENACOM (Ente Nacional de Comunicaciones) for wireless and telecommunications equipment,and IRAM/Secretaría de Comercio for electrical safety and energy efficiency.
